ANNOUNCEMENTS FROM THE COLLEGE AND/OR DEPARTMENT

PROGRAM UPDATES

BRUCE IS BACK

Bruce Elgort spoke about updating his Python course using Harvard University's version. It is used for CTEC 121: Intro to Programming and Problem Solving where the students have an opportunity to complete this course as well as earn a certificate from Harvard. It also auto grades and reviews the student's work immediately. Students can also be on whatever type of device and still be able to use and load software.

WINTER AND SPRING SCHEDULE

Adam Coleman spoke on pathways where students know what they are doing throughout each quarter.

Tom Strobehn suggested looking up CMMC Compliance. There is a huge demand and many clients do not know about it. It is Department of Defense compliance. Any IT professional that touches any type of CLI (classified information) needs to be certified under this.

Paul Yee offered some old laptops to the students to be allowed to use them.

INDUSTRY UPDATES

Tom Strobehn stated that cybersecurity is the big draw. The big change has been the knowledge. Many clients aren't getting the full coverage of security on their companies.

Paul Yee explained that much of the business is related to the automotive sector. With the parts supply issues and slowing sales, it has been very rough. They are currently going through some audits. Business is starting to pick up a bit more even though the economy is slowing down.
